## THE POSITION:

#### Duties:

Under the supervision of the Community Risk Reduction Chief, the seasonal Fire & Life Safety Inspector will perform, coordinate, plan, and implement fire & life safety inspections – specifically, as it pertains to defensible space, short-term rentals, construction, change-in-use, and annual compliance. Most inspections will be performed without direct supervision. The inspections will follow and adhere to State, County, and Local statutes. The Fire & Life Safety Inspector will maintain records and database information regarding all inspections performed. Other duties may be assigned as needed.

#### <u>Schedule:</u>

A seasonal Fire & Life Safety Inspector with the Northstar Fire Department will work 40-hours, five days a week. The schedule will include weekends and holidays. A typical work week will be five days a week. This position will be from May 15<sup>th</sup> to November 15<sup>th</sup>, 2019. Exact dates subject to change.

#### Compensation:

A seasonal Fire & Life Safety Inspector will be paid \$20 to \$25 per hour depending on previous experience, skills, education, and certifications. Overtime will be paid at time and a half after working more than 40 hours in a week. Sick time is accrued at 1 hour for every 30 hours worked, to a maximum of 72 hours. There are no other benefits such as health insurance, health reimbursement account contributions, vacation time, etc.

## THE SELECTION/APPLICATION PROCESS:

#### The Selection Process:

The selection process may include any or all of the following: application review, resume review, reference review, oral testing, written testing, physical testing, and/or a full or partial assessment center. The final appointment is contingent upon a check of past employment, personal references, Chief's interview, passing a district paid pre-employment medical exam, background check, and a drug/alcohol screening.
