Applicable building codes and standards must be noted on the cover sheet, including the NFD Amended fire code.

Plot plan must show distance from tank location to neighbor's property line and/or other structures.

Plot plan must show location of the trench and the second stage regulator.

Cut sheets for tank.

Cut sheets for pipe.

Cut sheets for regulator.

Type of fill sand/dirt.

Stake identification colors/location.
